ORDER

No. SAW/HD/COVID-19/2020/50: In continuation of this department order of even no. dated: 27.08.2021 and decision taken in today's NCOC meeting dated: 14.09.2021 regarding special NPIs for selective high disease prevalence districts of Khyber Pakhtunkhwa and declaration of emergency in the province by health department vide notification No.SOG/HD/1-102/Covid-19/2020/1517, dated 28.06.2021, the power conferred under section 6(b), section 6(d), and section 7 of "**Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020**", the competent authority, is pleased to issue the following further instructions / restrictions for high disease prevalence city (**Bannu**) w.e.f 16th September till 22nd September, 2021:-

- i. All commercial activities, establishments, markets shall be closed by **08:00 pm** in the province except all medical services & pharmacies/ medical stores, vaccination centres, tandoor, milk/Dahi shops, E.Commerce (Home Delivery), Utility Services (Electricity, Natural Gas, Internet, Cellular Network/Telecom, Call Centres) petrol pumps and agricultural machineries shops/ workshops.
- ii. All types of Commercial activities, establishment, markets shall be completely closed for **two days** in a week **Friday Saturday**
All medical services & pharmacies/ medical stores, vaccination centres, milk shops, tandoor, tyre puncture shops, petrol pumps and agriculture machineries shops/workshops shall remain open **24/7**, while general /karyana stores, meat/chicken shops, bakeries, fruit & vegetable shops will be open upto **10:00 pm**. except hotels/restaurants (outdoor/indoor dining upto 11:59 pm and for takeaway 24/7).
- iii. Outdoor marriages will be allowed with maximum **400 x guest** with strict COVID SOPs compliance. However, indoor marriage will remain banned
- iv. All types of indoor gathering including cultural, musical, events shall **remain banned**. However outdoor gathering allowed with maximum **400 x individual** under strict COVID protocols
- v. Indoor dining is completely banned however; outdoor dining allowed till **11:59 pm** under the strict COVID protocol. Take away are allowed are 24/7
- vi. All public and private offices/departments shall continue work with full/ **50% attendance** (workforce).
- vii. Wearing of **face masks** is mandatory at all public places.
- viii. The public transport, intracity, intercity and inter provincial are allowed to operate at **50%** of capacity with strict implementation of SOPs including wearing of face mask. Ban is imposed on all type of snacks serving to the passengers during journey by the transport services.
- ix. Shrines will continue remain closed.
- x. Cinemas will continue to remain closed
- xi. All types of contact Sports (Karate, Boxing, Martial Arts, Rugby, water polo, Kabaddi & Wrestling), festivals, cultural and other activities and events shall remain banned.
- xii. All amusement parks, water sports and swimming pools are allowed to continue at **50%** of capacity. Public parks will remain open with strict adherence of **COVID SOPs**.

- xiii. All types of indoor Gyms will be open only for vaccinated individuals / members. Mandatory vaccination of Gym staff / management will be sole responsibility of owner.
- xiv. Broader lockdowns with stringent enforcement of protocols based on risk assessment shall be ensured. No mobility shall be allowed except for emergencies.

2. Wide media coverage highlighting punitive actions against the violators shall be ensured by Information department and district administration.

District administration and Police shall work in close liaison to ensure strict implementation of this order and the violator of the above instructions / restrictions shall be penalized under the relevant law.
