## NOTIFICATION

No. 1/1 SO(S-1)/HD/2019: In supersession of all notifications / orders previously issued by this department in this regard, the Divisional Intelligence Coordination Committee is hereby reconstituted in Khyber Pakhtunkhwa comprising the following to review & measure the threat perception and share necessary Intelligence information for security in the respective Division with immediate effect:

### Divisional Intelligence Coordination Committee (DICC)

i.	Commissioner	Convener
ii.	Capital City Police Officer for Peshawar Division / Regional Police Officers	Members
iii.	Deputy Commissioners in the Division	Member
iv.	Superintendent of Police (CTD)	Member
v.	Rep: of Special Branch	Member
vi.	Rep: of ISI	Member
vii.	Rep: of IB	Member

### The TOR's of Divisional Intelligence Coordination Committee (DICC) shall be as under:-

1. The Committee shall hold regular meetings at least once in a month
2. Taking cognizance of local level threat information and sharing the same with Provincial Government.
3. Action taken on information disseminated to Divisional Intelligence Coordination Committee.
4. Preemptive action on activities of proscribed organizations including public gathering etc.
5. Identification and sharing of information regarding moveable and immovable assets belonging to individuals / entities proscribed / listed under UNSC 1267 sanctions or persons / entities action on behalf of or at the directions of these individuals or entities.
6. Locating / identification of persons / organizations acting on behalf of or at the directions of the proscribed / listed individuals.
7. Continuous monitoring of implementation of sanctions, against listed entities and individuals.
8. Preparation of data base of elements / associates including Madaris, Masajids, Hotels, Khanqahs, Serais, Residential Buildings, Shops especially those involved in Harboring of terrorist elements, Local Master Minds Harbors, Financers etc.
9. Identification of likely targeted buildings / persons.
10. Assessment of reported threats to individual / places and recommendations.
11. Arrest and removal of vagrants.
12. Combing Operations in likely hideouts of terrorists.
13. Threat assessment and provision of foolproof security to foreigners especially Chinese working / visiting / residing in the respective divisions, by implementation of SOPs issued by the Home Department for the purpose.
14. Monitoring and reporting of sale, purchase and transport of explosives in accordance with relevant laws.
15. Ensuring removal of fireworks, fissile material and Mortar shells etc. from residential areas, scrap shops and open market.
16. Ensuring action against illegal sale of Cell Phones and Sims.
17. Ensuring security of important / sensitive / Key / vital installations.
18. Monitoring and reporting of non-mandated activities of NGOs / NPOs / INGOs in the manner prescribed under the law / rules / policy.
19. Performing any other task assigned by the government. The Convener may co-opt a member from any other department / agency for the purpose.
20. The members of the Committee shall perform functions / duties within their respective organizational mandate.
21. Any subject of a primary importance for discussion / decision received from District Intelligence Coordination Committee.
