ORDER

No. SAW/HD/COVID-19/2020/71: In continuation of this department of order of even no.SAW/HD/COVID-19/2020/68 dated: 20.01.2022. keeping in view due to increase in positivity rate of COVID-19 cases in some cities of the province, which is constantly rising and leading to the “fifth” waves and recent decisions taken in NCOC session dated: 21.02.2022, and declaration of emergency in the province by health department vide notification No.SOG/HD/1-102/Covid-19/2020/3757, dated 31.12.2021, the power conferred under section 6(b), section 6(d), and section 7 of “Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020”, the competent authority is pleased to issue the following instructions/restrictions for city/district(Mardan) with positivity above 10% with effect from 22nd February,2022:-

- i. All commercial activities, establishments, markets/ business activities to continue without time restriction in the province.
- ii. There shall be complete ban on indoor weddings. However, outdoor shall be allowed for fully vaccinated individuals with maximum limit of 300x guests under strict implementation of COVID-19 SOPs.
- iii. There shall be complete ban on Indoor gathering. However, Outdoor gathering shall be allowed only for fully vaccinated individuals with maximum 300 x individuals.
- iv. There shall be complete ban on Indoor dining. However, outdoor dining shall be allowed for fully vaccinated under strict implementation of COVID-19 SOPs. Takeaway / home delivery shall be allowed 24/7.
- v. All public and private offices/departments shall continue work with fully 100% attendance (workforce). All employees must be fully vaccinated.
- vi. Wearing of face masks is mandatory at all public places throughout the province.
- vii. Public transports are allowed to operate with maximum occupancy level at 80% for fully vaccinated individuals under strict implementation of COVID-19 SOPs. Ban is imposed on all type of snacks serving to the passengers during journey by the transport services till 28th February, 2022.
- viii. Shrines are allowed to open at 50% capacity for fully vaccinated individuals only.
- ix. Cinemas are allowed to open at 50% capacity for fully vaccinated individuals only without time restriction.
- x. There shall be complete ban on contact Sports (Karate, Boxing, Martial Arts, Rugby, water polo, Kabaddi & Wrestling)
- xi. All amusement parks, water sports and swimming pools shall be allowed at 50% capacity for fully vaccinated individuals only. Public parks will remain open with strict adherence of COVID SOPs.
- xii. All types of indoor Gyms shall be allowed at 50% capacity for fully vaccinated individuals / members.
- xiii. Broader lockdowns with stringent enforcement of protocols based on risk assessment shall be ensured. NCOC will regularly share heat maps with federating units for implementation of targeted SLDs/mSLDs.

- xiv. Tourism in the province is open for vaccinated individual only with stringent protocols SOPs of COVID-19 to be ensured by tourism department.
2. Wide media coverage highlighting punitive actions against the violators shall be ensured by Information department and district administration.
3. This order shall come into force with immediate effect.
- District administration and Police shall work in close liaison to ensure strict implementation of this order and the violator of the above instructions / restrictions shall be penalized under the relevant law.
