THEIR APPOINTMENT SHALL BE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

1. Their Services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Khyber Pakhtunkhwa Prosecution Service and the rules made there under.
2. They will get pay at the minimum of BS-16 including usual allowances as admissible under the Rules. They shall also be entitled to annual increment as per existing policy.
3. They will be initially, on probation for a period of one year extendable for a further period of one year.
4. In case any one wishes to resign at any time, fourteen days (14) prior notice shall be necessary or in lieu thereof fourteen days (14) pay shall be forfeited.
5. They will produce a medical certificate of fitness from Medical Superintendent of District Headquarter Hospital concerned and character certificate from two Gazetted Officers.
6. Their appointment is subject to satisfactory verification of the antecedents by police, domicile certificate, testimonials by the concerned authorities/officers.
7. Their appointment is liable to be terminated at any time without assigning any reason before the expiry of the period of probation/extended period of probation, if their performance during this period is not found satisfactory.

9. If the offer of appointment is acceptable to them on above conditions, they should report for duty to the Directorate of Prosecution within 15 days of the issuance of this order.


