ORDER

No. SAW/HD/COVID-19/2020/55: In continuation of this department order of even no. dated: 15.10.2021, and decisions taken in NCOC session dated: 28.10.2021. keeping in view that a considerable populace has been vaccinated; hence, forum decided to incentivize high vaccination cities through return to normal life / relaxation in NPIs, and declaration of emergency in the province by health department vide notification No.SOG/HD/1-102/Covid-19/2020/3392, dated 15.09.2021, the power conferred under section 6(b), section 6(d), and section 7 of “**Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020**”, the competent authority is pleased to issue the following instructions/restrictions for being low vaccination progress cities except **Peshawar, Chitral, Mansehra(Balakot)** with effect from **16th to 30th November 2021:-**

- i. All commercial activities, establishments, markets shall be closed by **10:00 pm** in the province except all medical services & pharmacies/ medical stores, vaccination centres, tandoor, milk/Dahi shops, E.Commerce (Home Delivery), Utility Services (Electricity, Natural Gas, Internet, Cellular Network/Telecom, Call Centers) petrol pumps and agricultural machineries shops/ workshops.
- ii. **The restriction of a closed day in a week is discontinued all over the province.**
- iii. Outdoor marriages will be allowed for fully vaccinated with maximum **500 x guest**. However, indoor marriage / function will be allowed **only for fully vaccinated individuals** with maximum **300 x guests**.
- iv. Indoor gathering allowed only for fully vaccinated individual with maximum limit of **300 x individual**. Outdoor gathering allowed only for fully vaccinated individuals with maximum **1000 x individuals**.
- v. Indoor and outdoor dining is allowed for fully vaccinated individuals till **11:59 pm**. Indoor dining is **at 50% occupancy** is allowed. Takeaway / home delivery are allowed **24/7**.
- vi. All public and private offices/departments shall continue work with fully **100% attendance** (workforce). All employees must be fully vaccinated.
- vii. Wearing of **face masks** is mandatory at all public places.
- viii. The public transport, intercity, intercity and inter provincial are allowed to operate at **70% to 80%** of capacity for vaccinated individuals only and is allowed to operate 7 days a week with strict implementation of SOPs including wearing of face mask.
- ix. Shrines are allowed to open for fully vaccinated individuals only.
- x. Cinemas are **allowed to open** for fully vaccinated individuals only without time restriction.
- xi. All types of contact Sports (Karate, Boxing, Martial Arts, Rugby, water polo, Kabaddi & Wrestling) are allowed for fully vaccinated individuals only.
- xii. All amusement parks, water sports and swimming pools are allowed to continue at **50%** of capacity. Public parks will remain open with strict adherence of **COVID SOPs**.

- xiii. All types of indoor Gyms are open only for fully vaccinated individuals / members.
- xiv. Broader lockdowns with stringent enforcement of protocols based on risk assessment shall be ensured. NCOC will regularly share heat maps with federating units for implementation of targeted SLDs/mSLDs.
- xv. Tourism in the province is open for vaccinated individual only with stringent protocols SOPs of COVID-19 to be ensured by tourism department.
2. Wide media coverage highlighting punitive actions against the violators shall be ensured by Information department and district administration.

District administration and Police shall work in close liaison to ensure strict implementation of this order and the violator of the above instructions / restrictions shall be penalized under the relevant law.
