ORDER

No. SAW/HD/COVID-19/2020/40: In continuation of this department notification of even no. dated 28.06.2021 and today COVID update presented by NCOG; the Honourable Prime Minister approved the stringent measures for high disease prevalence cities in this regard and declaration of emergency in the province by health department vide notification No.SOG/HD/1-102/Covid-19/2020/3062: dated 30.06.2021, the power conferred under section 6(b), section 6(d), and section 7 of “**Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020**”, the competent authority is pleased to issue the following instruction / restrictions for high disease prevalence cities (**Peshawar, Abbottabad**) in the province till 31st August,2021, for strict compliance with effect from 3rd August 2021:-

- i. All commercial activities, establishments, markets shall be closed by 08:00 pm in these districts except all medical services & pharmacies/ medical stores, vaccination centres, tandoor, milk/Dahi shops, hotels/restaurants (outdoor dining upto 10:00pm and for takeaway 24/7), E.Commerce(Home Delivery), Utility Services(Electricity, Natural Gas, Internet, Cellular Network/Telecom, Call Centers) petrol pumps and agricultural machineries shops/ workshops.
- ii. All types of Commercial activities, establishment, markets shall be completely closed on two consecutive days (choice of days is on the discretion of district administration) in a week except the following with effect from 3rd August 2021:
All medical services & pharmacies/ medical stores, vaccination centres, milk shops, tandoor, tyre puncture shops, petrol pumps and agriculture machineries shops/workshops shall remain open 24/7, while general /karyana stores, meat/chicken shops, bakeries, fruit & vegetable shops will be open upto 8:00 pm. except hotels/restaurants (outdoor dining upto 10:00 pm and for takeaway 24/7).
- iii. All types of indoor marriages / functions shall be banned w.e.f 8th August 2021. Outdoor marriages will be allowed with maximum 400 x guest with strict COVID SOPs. Timings for outdoor weddings will be till 10:00 pm.
- iv. All types of indoor gathering including cultural, musical, and religious etc events shall remain banned; however, outdoor gatherings will be allowed for maximum 400x individuals under strict COVID protocols.
- v. Indoor dining in the restaurants is banned. However outdoor dining will be allowed till 10:00 pm. Takeaway / home delivery shall be allowed 24/7 with strict implementation of COVID-19 SOPs.
- vi. All public and private offices/departments shall observe their respective normal office timings.
- vii. All public private offices and establishments shall reduce their attendance from 100% to 50% and shall strictly follow this policy.
- viii. Wearing of face masks is mandatory at all public places and innovative measures would be adopted for its compliance.
- ix. The public transport, intracity, intercity and inter provincial are allowed to operate at 50% of capacity with strict implementation of SOPs including wearing of face mask. Ban is also imposed on all type of snacks serving to the passengers during journey by the transport services.
All cinemas and shrines shall be closed.

- xi. All types of contact Sports, Karate, Boxing, Rugby, Water Polo, Kabaddi, wrestling and other activities and events shall remain banned.
 - xii. All amusement parks, water sports and swimming pools shall be closed; however public parks will remain open with strict adherence of COVID SOPs.
 - xiii. All types of indoor Gyms will remain open only for vaccinated individuals / members. Mandatory vaccination of Gym staff / management will be sole responsibility of owner.
 - xiv. Broader lockdowns with stringent enforcement of protocols based on risk assessment shall be ensured. Targeted SLDs/mSLDs will be ensured by the districts in light of the heat maps, to be shared by NCOG.
 - xv. Policy of controlled tourism for vaccinated individuals will continue and will be ensured by district administration.
2. District administration and Police shall work in close liaison to ensure strict implementation of this order.
- The violator of the above instructions / restrictions shall be penalized under the relevant law.
